



Enrolling in 2025 National Board of Echocardiography's MOTE/MOCE

Since MOCE is an annual process, **yearly enrollment is required**, through your NBE profile before Testamurs and Diplomates can access questions in the aimeQED platform.

Steps to Enroll in MOTE/MOCE

Step 1 - Log into your NBE profile at www.echobboards.org using your 8-digit NBE ID number as the username (example: 00012345) and your previously created password. (If you do not know your NBE ID number or password, please use the forgot password option on the sign-in page or contact info@echobboards.org for assistance.)

Step 2 - Once you have logged in to your profile, hover your cursor over the **MOCE/MOTE** menu header at the top right of your profile page.

Step 3 - Select your NBE specialty pathway from the dropdown menu corresponding to any Testamur or Diplomate status you have achieved.
Examples: MOTE_ASCE is Testamur of the ASCeXAM; MOCE_ADVPTE is Diplomate of the Advanced PTEeXAM, etc.

Step 4 - On the next page, click the blue **Create New Application** button. This will take you to the instructions page for the online enrollment process.

Step 5 - Complete the enrollment questions and attestations and complete the cart checkout.

MOCE/MOTE Fees: If your Testamur or Diplomate status has expired (valid through date is 12/31/2024 or earlier), you will see the \$85.00 fee in your cart at checkout. If your Testamur or Diplomate status has not yet expired (valid through date is 12/31/2025 or later), you will see \$0.00 in your cart at checkout.

Multiple Specialties: If you have Testamur or Diplomate status in more than one specialty (e.g., ASCeXAM and CCEeXAM, Basic PTEeXAM and Advanced PTEeXAM), you will enroll in each separately and pay any applicable fees for each.



First-Time MOCE/MOTE (aimeQED) Users:

You will receive a welcome/activation email from donotreply@aimelarning.com, which will be sent after 10:00 a.m. EST the next business day (for example, if you enroll on Wednesday, Feb. 26th, you should receive your email after 10:00 a.m. EST on Thursday, Feb. 27th). This email will contain instructions on activating your aimeQED account and logging in to answer questions in the aimeQED platform for MOCE.

Returning MOCE/MOTE Users (previously activated your aimeQED account):

Your aimeQED account will reactivate after 10:00 am EST the next business day (same example from above). Then, log into www.aimelarning.com or the aimeQED app to answer questions.

Important Reminders:

- **Google Chrome is the most compatible browser** to answer questions on www.aimelarning.com. You can also download the mobile app from your phone's app store.
- Completion of annual MOCE/MOTE standards requires 48 questions total to be answered before 11:59 PM EST on December 31, 2025, and you must maintain a 0.20 or greater MDT Value.
- If you want to claim CME, which will be available after the December 31, 2025, deadline, you **must** have answered all 48 questions in 2025. [Click here](#) for more information.
- Beginning with the enrollment launch in February, twelve (12) additional questions will be released on the first day of quarters 2, 3, and 4.
- You can answer a daily maximum of 12 questions.
- On January 1, 2026, any unanswered questions will be marked as incorrect, which may affect your MDT value.
